RESOLUTION RATIFYING SETTLEMENT AGREEMENT FOR THE KIPP AVENUE PUMPING STATION PROJECT

WHEREAS, the City of Garfield (“Garfield”) put out for a bid a project located in Elmwood Park known as the Kipp Avenue Pumping Station (the “Project”) in cooperation with the County of Bergen and as required by the New Jersey Local Public Contracts Law; and

WHEREAS, All County Pipeline and Site Excavation, Inc. (“All County”) was the lowest responsible bidder and therefore was awarded the contract for the Project; and

WHEREAS, Garfield and All County have been engaged in a business relationship with All County performing work as the prime contractor on the Project pursuant to a certain written agreement dated April 10, 2013; and

WHEREAS, All County has defaulted under the Contract for, among other things, failure to perform and abandonment; and

WHEREAS, The City has terminated All County as of September 25, 2014; and

WHEREAS, Avicorp, LLC (“Avicorp”) entered into an agreement with All County where it agreed to indemnify All County and provide same with a performance and payment bond for the Project issued by First Fidelity Lending Corporation (“First Fidelity”); and

WHEREAS, PCS Pump and Process, Inc. (“PCS”) as supplier to All County alleges that All County failed to properly pay \$31,600.00 for services, work and/or materials furnished to the Project; and

WHEREAS, on September 16, 2014, PCS asserted a Municipal Mechanics Lien in the amount of \$31,600.00 for said service, work and/or materials furnished to the Project; and

WHEREAS, Stewart & Stevenson Power Products, LLC (“Stewart & Stevenson”) as supplier to All County alleges that All County failed to properly pay \$31,000.00 for services work and/or materials furnished to the Project; and

WHEREAS, on November 1, 2014, Stewart & Stevenson asserted a Municipal Mechanics Lien in the amount of \$31,000.00 for said service, work and/or materials furnished to the Project; and

WHEREAS, Weldon Materials, Inc. (“Weldon”) as supplier to All County alleges that All County failed to properly pay \$5,084.64 for services, work and/or materials furnished to the Project; and

WHEREAS, on May 13, 2014, Weldon asserted a Municipal Mechanics Lien in the amount of \$5,084.64 for said service, work and/or materials furnished to the Project; and

WHEREAS, Garfield, in conjunction with Avicorp, has agreed to settle the outstanding claims and pay the above-referenced suppliers and/or subcontractors a negotiated amount to resolve the Municipal Mechanics Liens in place, and it is in the best interest of the City of Garfield to avoid the additional costs and uncertainties of litigation, and the claims paid by Garfield will be resolved solely from the funds appropriated by Garfield for the Project; and

CITIZENS AND TAXPAYERS

Mr. Mo Kinds, 104 Dewitt Street, spoke on graffiti and spray painting throughout his neighborhood and how there is a need to address this issue.

He said that trees need to be cut down near the pedestrian bridge over Fleisher's Brook at the end of DeWitt Street. He complained about couples in cars in the back parking lot of the Venetian located at 546 River Drive.

Mr. Stephen Lawson, 205 Wessington Avenue, said that he witnessed a brawl between two kids, then a white Honda Civic emptied out on Outwater Lane near Wessington Avenue. He said that more surveillance cameras should be installed in the neighborhood. He spoke on graffiti in town. He spoke on protecting his four year daughter. He spoke on gangs.

Pastor Arthur Bryant, Friendship Baptist Church, 154 Gaston Avenue, spoke on gang activity in Garfield and the surrounding towns. He spoke on children being neglected. He spoke on the need for organized activities for children, especially if they do not feel accepted at home. He spoke on developing plans for children and he said that the first priority is young people.

Ms. Judy Fraser, 88 Prospect Street, spoke on reaching out outside of Garfield to County and State agencies for assistance with City Gang activities.

COUNCILMEMBER COMMENTS

Councilmember Calandriello said that he understands that there was a State Office of Civil Rights team from Washington who did some interviews in our school system to see if there were any neglect or complaints. He asked if a copy of their report can be obtained. He said the problem of gangs needs to be addressed by the City, School Board, Housing Authority and Houses of Worship. He said that we have situations that are changing as we speak. He said that this is a community problem and that is how we have to address it. He said "we start with the safety of our citizens, we start with the safety of our children". He spoke on the proposed demolition of old Fire House No. Three located on Willard Street. He spoke on the growth surrounding the property. He spoke on Vornado granting land to the City and the search for any records indicating that. He said that he attended the Girls Softball Dinner and he said that the Garfield Junior Boilermakers Football season has started.

Councilmember Aloia said that there are some great things going on in Garfield. He said that his grandson goes to karate at the YMCA. He said that when you make a commitment, you have to live up to the commitment you make. He said that a man had his handicapped ramp stolen from the front of his home in Garfield. He complimented Fire Company No. 3, who he said arranged to have Allied Medical Supply set up a new ramp, but they were too slow, and the boy scouts went and built a ramp last week. He said that it was an unfortunate situation, but it is a small percentage of kids who cause havoc. He said that good things sometimes happen after a bad situation.

Councilmember Mati said that there is an obligation to protect people's life and property. He said that high Police visibility and additional Police Protection is what is needed. He said that there is a small percentage of bad kids and he spoke on gang officers in the Garfield Police Department. He said that Congressman Bill Pascrell was at Garfield High School focusing on concussion prevention regarding kids and our servicemen. He said that it was a good thing for kids to learn about. He said that there are positive things going on in town.

City Manager Thomas J. Duch spoke about the Calvary Baptist Church Cancer Walk scheduled to be held on October 11<sup>th</sup>, which requires a Special Events Permit. A motion was made by Councilmember Aloia and Seconded by Deputy Mayor Mati to authorize City Manager Duch to proceed with approval of the permit.
